THEN DO WE, OR DO WE NOT, BY THE AUTHORITY OF DEMOCRACY, have the right to declare a tax strike. Call for accountability from our employees. And have the constitutional authority within ourselves to make the changes in governing our lives, that we see fit. Assert what is true/ declare what is not true, and support that in clear and certain terms consistent with the need: WE THE PEOPLE shall understand.
