RE: a case developed to determine two distinct questions/ what is proper and fair in the billing dispute between the plaintiff and the defendant for services rendered. And what is proper and fair in the billing between the citizens of this nation, and the medical industry as a whole. The proper channel is a legal resolution for both/ the foundation of this case is: that REDRESS OF GRIEVANCES, according to the first amendment is the correct method to create a disciplined, orderly, confirmation of what is justice and fair play for all.

The champaign courtroom, defines and determines for the individual. The LAW called redress of grievances within the first amendment to the US constitution defines and determines for the nation; according to the vote of the people themselves. There can be no dispute as to the controversy in healthcare costs across this nation. Therein the right to ask for redress needs no further consent. Rather let the people decide for themselves. This then exercises the right of a citizen to say to the employees of his government: OBEY THE LAW. To the government of we the people, an opportunity called DEMOCRACY!

Let there be NO misunderstanding: this courtroom cannot decide for a nation/ that would be “*simply another political solution (a few people voting and deciding for the whole people)*”. This is a legal solution, a demand for THE DECISION OF democracy as created through the constitution for dealing with any crisis: which means simply, after examining the evidence, investigating the cause, and developing a clear and concise description of what our future will be: **THEN ONE PERSON, SHALL CAST ONE VOTE, to decide by redress what we the people SHALL BE RESPONSIBLE FOR.** It is our nation, this is our democracy: and that legally means, one citizen equals one vote to determine our future & our reality as a nation.

Preliminary opening statement:

The qualifications and disciplines necessary to understand this case are SIMPLE; the law allows for redress of grievances according to the first amendment. Therein, apart from the fundamentals of a billing dispute between Provena and myself/ the reality sought for America itself is distinguished as the same. An end to the dispute of money, by a decision both just and wise from the people themselves. The legal resolve of money issues, between the citizen and the medical industry; is NECESSARY. The political process has proven to be unable, corrupt, and without the ability to understand money. *This is a vote of NO CONFIDENCE in our employees for the nation; and that has consequences.*

The functional resolve of understanding healthcare is VERY SIMPLE: when WE THE PEOPLE find our bodies attacking us, in ways that may or may not be defeated/ when the war inside or outside a body can result in life, death, mutilation, disabilities, loss of income, basic functions and the rest. When we are no longer at peace with our bodies, it is critically true: “We simply have to take what we get, from those in the business of medicine in its various forms; leaving us all without options to contest the work, the billing, or the method. We are entirely dependent upon what we cannot control by individual means. It can be necessary to allow other people to intervene in our behalf, regardless of the outcome, because the physical price for being wrong is harsh. These people are called the medical industry for all intents and purposes, participating as every aspect of “healthcare” in this UNITED STATES OF AMERICA. Consequently every portion or part, tied to the body or mind of work or influence on a life; is being decided in this trial.

That said, it is important to understand and recognize: we the citizens of this USA do appreciate medical intervention/ and although these people are not nearly what they believe they are in terms of knowledge and understanding of the body; perhaps 80% of the time, DUE primarily to antibiotics, the results are generally better for the majority; than if we had not allowed or accepted their help. The tragedy of failure, a consequence “we are human/ wherever no criminal intent or functional stupidity exists”; MUST be addressed in that manner. The consequence of our reality, does put every citizen at the mercy of the healthcare industry/ and that means, when we know, literally

life or limb, etc can be lost; the ease and forms of extortion, and excess billing can be rampant; as is today. “Its just business” IS NOT good enough! This is NOT open to debate; this nation has been dealing with the healthcare issue for months now, with the majority of the nation critically divided on political intent; as to HOW TO CORRECT THE BILLING PROBLEMS!

Because it is NOT the fundamentals of medicine that we the citizens of this USA are at odds with/ IT IS THE FINANCIAL COST of the healthcare industry that has brought on us all, this crisis of healthcare in this USA. We, are at odds with the money charged/ and that means the resolution of this problem will include a reduction in the charges of this medical industry; and nothing else will do. Functionally identified as: *by one estimate total current healthcare expenditures in this USA are 5 trillion dollars per year. In a nation of approximately 50 million full time workers: 5 trillion dollars represents an annual expenditure per worker of one hundred thousand dollars. \$100,000.00* OBVIOUSLY A FANTASY & DELUSION, as this is impossible. **The lies must stop. BEFORE the nation is completely ruined.** The politicians have produced nothing, because greed controls.

I do not seek a political solution, as that has been tried for decades now. I do not believe in the presidential solution, or the solution of legislatures. It is clear WE THE PEOPLE are not satisfied with either solution or the political realities of this day, either. Consequently this lawsuit, while dealing with a personal billing issues/ seeks to resolve all billing issues for me, and for us all: with an absolute resolve for honesty, truth, justice, and fair play to all sides for the future. That is NOT

done, by twelve jurors, in this courtroom at this time/ because that would conform to simply a different style of political issue or idea.

RATHER, THE FUNCTION OF REDRESS OF GRIEVANCES, ACCORDING TO THE FIRST AMENDMENT IS: to establish an accounting before the people themselves, from all parties/ that we may each understand the issues that MUST be resolved legally: and turn to ourselves as WE THE PEOPLE to decide what that solution must be. Redress of grievances IS DEMOCRACY IN FULL AND SUBSTANTIAL ACTION. It is taking control of government for ourselves, thereby confronting what has become a literal and true crisis (as seen by the numbers above)/ and MAKING OUR DECISION, BY VOTE for the future of our own lives, this nation, and these children who depend upon us.

This is NOT a game, the fantasy and delusion are over/ and that means LITERAL, AND HARD CHOICES SHALL BE MADE. But in terms of this courtroom, as the defense has taken it upon itself to prescribe: WE BEGIN THIS JOURNEY INTO TRUE DEMOCRACY, and the foundation of law called the first amendment, by asking 12 jurors if they do so agree: that we the people MUST take over and resolve the healthcare crisis in America or not. If they say yes, then Redress of Grievances becomes either a “champaign county/ OR a state of IL” vote; to determine if we shall demand of this nation, called we the people: a full and complete REDRESS OF GRIEVANCES, by the first amendment of the UNITED STATES CONSTITUTION, “As WE THE PEOPLE” or not. If that shall be true YES, then this nation

goes to court, within the resolve and purpose of learning the truth about its own reality/ to hear the witness and testimony of industry and humanity: ***so that these citizens MAY MAKE THE DECISION THAT WILL DETERMINE THEIR OWN LIVES, in this future, and in this time. THEN, to court before the world we shall go. If not, THEN this case is dissolved, redress ends.***

***That is the purpose of this trial. To decide, IF WE THE PEOPLE will take it upon ourselves, to determine our future. One citizen, one vote.***

As to the reality of this plaintiff, my desire is to resolve the personal billing issue/ and complete the fair and legitimate legal resolution of this healthcare crisis in AMERICA by representing the people, as the plaintiff for WE THE PEOPLE. Through the introduction of attorneys: for the people/ NOT for me. These shall be: Provided by the court, if redress is confirmed.

As to the reality of this defendant, Provena Covenant Medical center; they must resolve the personal billing issue with me. But apart from that, they may or may not choose to represent the entire medical industry; as is their desire to do. REDRESS OF GRIEVANCES IS A DEMAND OF THIS THE AMERICAN PEOPLE, it is not a game/ and it does not allow for anyone to ask or say “to be excused”. ***WE THE PEOPLE, are owners here/ and you will understand; that we the people of America/ the citizens who are this nation, its workers, and its life: choose to examine this crisis as has come upon our “doorstep”, and any other as we might so design/ so that OUR DECISION, becomes the future and the***

**reality we must bear. It is our right to decide.** The political reality of this day has proven unwise, incapable, and without sense: OR THIS TROUBLE, would not have come.

This IS A CHOICE, provided by the first amendment of the United States Constitution, and the employees shall obey, OUR LAW. IF THE PEOPLE BY VOTE, determine for themselves, that they will take control, there is nothing any employee can say against them. We, are entitled to our constitutional guaranteed rights, and choose to enforce them today.

As to the reality of this courtroom: its primary purpose is to initiate the consequence and demonstrate the reality in truth: OF WHAT THE PURPOSE AND TRUTH, OF THE FIRST AMENDMENT REDRESS OF GRIEVANCES, for WE THE PEOPLE; According to the United States Constitution functionally means.

As this is a national legal foundation for resolving any and all trouble, **established as a crisis or potential crisis in this nation** by which the people themselves declare “no confidence in the politicians/ our employees”. Redress then becomes, “a cost in all aspects of media, information, legal, etc:

of the nation for itself”. BECAUSE our reality is a crisis in other critical issues of this day, such as weapons of mass destruction, and more. It is fair and appropriate to establish within the vote, ANY AND ALL such trouble as to which this nation itself may then respond. EACH “CRISIS OF NO CONFIDENCE” in our leadership constitutes a different redress of grievances as shall “GO TO TRIAL, before the people themselves”. Each crisis will be established or abandoned, by

and because of the vote of the people themselves. Each crisis is separate from the others/ but in terms of a nation, EACH IS A MATTER OF SEVERE IMPORTANCE. Because a vote costs money, and takes time; all will be joined in just one vote/ just one trial, to be created at various locations, FOR ONE SINGLE PURPOSE. To decide as WE THE PEOPLE, what our future shall be /and who shall indeed rule our lives.

There can be no billing to either party involved as to the original litigants/ this is a national agenda, a redress for the nation; and it must be paid by the people themselves. As to the attorneys fees: those who will represent the people, as a nation asking for truth, SHALL provide “a contract, with full billing: for bidding purposes”. NO hours, no anything extra: the entire amount you will be allowed to charge/ regardless of how long it takes will be included in your bid. Per individual structured argument to be resolved/ if you are removed from the case prior to completion of this argument, by the representative of this people, James Frank Osterbur: YOU AGREE/ you shall NOT be paid. **A reality required to insure NO ONE SELLS US OUT/ NO TRAITORS ALLOWED.** As plaintiff for the people, it is my right to hire, or to fire as is consistent with the purposes of this redress. ***That purpose is: JUSTICE, HOPE, TRUTH, FAIR PLAY, RESPECT, NO GAMBLING WITH LIFE, LAW, EQUALITY, AND DEMOCRACY FOR REAL!*** The industry pays for, and provides their own.

As to the reality of constitutional interpretation, once this legal remedy as provided by & within the US CONSTITUTION has passed its initial trial, of twelve jurors: it is up to the voters of county or state; as described by this court: to



**decide if this is indeed the purpose of the first amendment  
redress of grievances of OUR UNITED STATES**

**CONSTITUTION or not.** WE ARE THE OWNERS, AND WE DECIDE AS REGARDS OUR OWN PROPERTY. No courtroom can take this right away/ no juror or judge or president or any other form of traitor. WE THE PEOPLE SHALL DECIDE!

IT IS OUR GUARANTEED RIGHT! By vote, as so described. As to the percentage necessary to agree, and constitute the resolve of this people, the foundation of democracy is: “Majority rule, by and within, constitutional decree! You can accept the rules governing votes of the legislature, speak to this.” As to the jury trial of twelve, should they be unanimous; respect states this then becomes a vote supported to, and requesting of an entire state of IL vote of this people for themselves. The other states may join if they so desire. Should the vote of this jury of twelve, be less than unanimous, but not less than 7 people who say yes, we must go to redress of grievances, because this nation is in crisis. Then it goes to Champaign County vote, and the percentage required to ask of the nation itself if they agree: TO REDRESS OF GRIEVANCES WE MUST GO. shall not be less than 70%, for the county FIRST (or, a number determined by the court, but not less than 50%/ nor more than 70%). Then the nation according to numbers like the legislature, as is required by the constitution.. Anything less than these numbers throughout the process; and this demand for the people of this UNITED STATES OF AMERICA disappears. They have said no. Or they will say yes. It is their right, and it will be their

work, their benefit or loss, and their future.

It is their decision, not yours, not mine, not the right of a judge to decide. BUT WE THE PEOPLE OURSELVES. One citizen equals one vote. Those with children less than the voting age, shall on proof of their existence, vote for their own children, as one parent representing one child= one plus, one half of an additional one vote; added to the total. This is the future of every citizen child too/ and they deserve a vote.

THE LEGAL ARGUMENT BEGINS: in this Democracy, as the foundation of our values, and the illustration of our purpose for being united in our destinies, as a nation. That foundation in words, is shaped by the preamble of this

UNITED STATES OF AMERICA,. CONSTITUTION.

And I quote:

***“We the people of the United States, in order to form a more perfect union, establish justice, insure domestic tranquillity, provide for the common defense, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity, do ....”***

***There is no ambiguity in “we the people”: IT GIVES NOT THE FATE OF THIS NATION, to any other employee. WE ARE THE OWNERS!***

***And there is no alteration of purpose, no possibility of defiance, in this REDRESS OF GRIEVANCES, for this people. 12 will speak for the state or county within which they reside/ and then the originating “state of ILLINOIS”, shall speak***

*for the nation.*

**TO DETERMINE IF THIS QUESTION, THIS REDRESS OF GRIEVANCES** AGAINST THE MEDICAL INDUSTRY, or any other crisis listed in the vote: ought or ought not be done. By their decision: the money, work, and time necessary to ask of this nation in its entirety; TO VOTE on the very same question fo redress shall be done. And by confirmation of a nation, REDRESS OF GRIEVANCES SHALL COMMENCE, AS THEY DESIGN. **Under the authority of WE THE PEOPLE, AS THIS DEMOCRACY** called: **THE UNITED STATES OF AMERICA!**

TO DECIDE AND DETERMINE: “OUR RIGHTS/ OUR FUTURE/ OUR RESPONSIBILITIES/ AND OUR HOPE FOR THE WORLD AND THIS NATION,” as best we can.

**The establishment of redress of grievances IS A LAW WRITTEN BY THE PEOPLE**, which will then govern their lives, this nation, these interests and industries, and our relationship to this world of life, and our future.

A DECISION IS REQUIRED, no crisis substantially required for examination, can be dismissed, without a true and consequential law. **THE PEOPLE WILL DECIDE**, and accept the cost of their decision, for good or for bad; regardless of what that is. It is your right, and it is your responsibility; **AS WE THE PEOPLE, OF THIS UNITED STATES OF AMERICA.** Should a law need to be revisited by the people, provisions shall be made to individually change the law, in years to come; by a percentage of voters that is greater than the percentage which

made the law. NO change will occur to any law, unless it defines the decision of a greater majority of the people; than those who made it come true. Prove it is not so!

**Because redress is about CRISIS IN AMERICA, and the fundamental foundation of a true need to act/ rather than wait to react, before things get any worse.** This reality of need envisions a direct route to court, critically determining the need to vote, by the people within no more than 60 days from its introduction to society; by the vote of this jury of 12. Because this is a crisis in reality, the need for any other state to vote except ILLINOIS is unnecessary, unless no fewer than 15 states demand all must vote: ILLINOIS will vote for the nation, because it begins here.

Preparations for court, begin immediately upon this vote affirmed as yes we will accept the responsibility and determine the direction and future of our lives, this nation, and our decision to fight for this world. Or not, as the case may be. If yes, testimony begins within 30 days thereafter, *WITH complete media access/ and absolute transparency; nothing can be hidden, and there is no “fifth amendment” to the constitution to hide behind; this is about the nation itself, and your individual rights are not equivalent to that.* This proceeds until the citizens of this United States of America, shall resolve every question that they have produced, within law, as the foundation required to make their own decisions. It is the courts job, to initiate and pay for all media attention as is necessary and fundamental for the nation, county, or state to accept and understand their job and duty; as citizens of this nation. **There is no need for massive**

**preparation, as crisis means: “Like it or not, we go as we are; as best we can”. In every crisis, TIME IS IMPORTANT!**

*BEYOND THE CRISIS IN HEALTHCARE BILLING: there are other more important demands for redress of grievances to be addressed/ as the people elect for themselves. Or not.*

2. There is a crisis in weapons of mass destruction.

a. Did you know, that biological weapons are expected to be 97% effective/ killing at least 97 people out of every one hundred. Who can doubt, the death surrounding the last few would kill them too? And that is only a tiny part of the plan to exterminate us all.

b. Did you know, as few as 25 atomic bombs can spell the end of this world/ or that one single missile holds more destructive capability than is necessary to completely annihilate New York City and all its surrounding area.

I) the solution is world law/ a world court/ and a world police **that bring the leaders of ANY nation to justice** for we the people of this world.

3. There is a crisis in “university and industry experimentation”. **They have surpassed the realities of discipline and order that have kept this world alive/** and now stand at the threshold of destroying this world with their gambling to “play god” with our world/ our nature/ and our lives.

a. **This world will die only once.** The people who can

and are deliberately trying to bring “the same fire that is on the sun, here to earth: where everything is fuel for an atomic fire”. Cannot be wrong, or every life on the planet will burn. How is that sane? There are many more experiments without sense, respect, or reason to exist.

II) the solution is to take away their machines/ and demand LIFE SHALL BE FIRST. No gambling with everything! The solution is to control the university in its entirety, and allow no more stupidity or **outright terrorism** to exist.

4. There is a crisis in genetic crucifixion; wherein the university and industry are attempting to “play god” and redesign life in their own image/ by their own terms.

a. **We are alive, because genetic discipline and design create balance and dignity as the bodies and the world we inhabit. We are alive, because NATURE NOT man has made our lives able to survive. We are alive, because there is order, chains of life, and separations between species. All of which the university, medical business, and industry are trying desperately hard to dissolve into chaos and disorder, with complete arrogance and disrespect. So they can learn to play god with life.**

III) either you will stop them completely, or nature dies, and you as well. As is true of everything else men have led you to: **THE END RESULT of their promises WILL BE ARMAGEDDON (the complete loss of genetic disciplines, balance, and order in every living thing. There is NO going back).**

5. There is a crisis in money. THE LIARS, THIEVES, & CHEATERS have sold this nation; and we are in debt far beyond “federal debt”. The media lies to you, forgetting to add: there is personal debt/ financial debt/ state and municipality debts/ business debt/ agricultural debts/ and more. A total of approximately \$105,000,000,000,000.00 trillion dollars. Or more simply a debt divided equally: **of \$344,262.00 per citizen** (babies and all, each and every single citizen for 305 million people). One trillion dollars equals the entire full time workforce of this nation approximately 50 million workers, multiplied by \$20,000.00 twenty thousand dollars per worker; per one trillion dollars. That’s the math.

a. We deserve an accounting from our employees/ we demand a critical and real understanding of what the truth is/ regarding debts and money. NO MORE LIES, everything! WITH SEVERE PUNISHMENT, for any who dare to lie.

IV) the solution is bankruptcy (removing the claims of the rich/ and redistributing the reality of work, resources, and life to the people).

6. There is a crisis in water. Across this nation water reserves are being lost in trillions of gallons: to energy recovery, ethanol production, pollution in many forms, and completely unsustainable practice.

a. With a calculated aquifer recovery rate of only one inch of rainfall, ending within the aquifer per every 50 inches of rain. The reality is: “our wells, are running dry”. The single

largest aquifer under the great plains “ogahalla” is expected to run dry within the next 15 years at a maximum/ and probably sooner. When it does, food production will drop, and the dust bowl of the thirties will return. 6000 years of aquifer accumulation gone, in less than one hundred. And who can live without water/ these places will be abandoned. Think.

b. There is currently a recent drain installed to empty the great lakes above Niagra falls. Men built a canal for shipping/ but failed to understand it is a drain/ and trillions of gallons are lost, with more to come. And there is more: an underground cavern that can swallow most of the great lakes themselves/ with just one tiny hole.

V) the solution, learn/ work/ do better/ and devise a situation you will survive.

7. There is a crisis in food. The bees, bats, and insects that pollinate our world are dying. The food is being genetically modified to end diversity, alter the genetic responses of all things which eat it, and is dependent upon realities and resources that will soon not be available such as some forms of fertilizers (potash in particular). The livestock are confined in arrangements so dense that they CANNOT survive unless antibiotics are fed to them in every meal/ every day; because a single sickness or disease can wipe them all out. That means as the antibiotics that keep us and them alive are lost, due to this horrific practice “pennies are more important than life”. Has a consequence: THERE WILL BE PANDEMIC’s to wipe entire herds, even species away; in less than one month. And there is no back up plan, NO method available today of raising



these creatures without antibiotics; because confinement does not work without them. A recipe for hell on earth/ as you fight to survive; and turn to cannibalism.

VI) Stop being insane. Stop the poisoning and mutilation of nature. Find solutions for a future you can survive. **CHOOSE DIVERSITY, BECAUSE TROUBLE WILL COME.** Follow truth, **LIFE MUST BE FIRST**, but let reality lead; or war will follow.

8. There is a crisis in environment. We **CANNOT** live without this planet in harmony with itself.

a) This list is very long, and requires the structured understanding of everything that survives. Everything that participates in life as a chain, or a reality including the oxygen we breathe.

VII) The solution is: **NO MORE STORIES**, no more games, we will investigate, examine, and decide: **UNDERSTANDING the future of life on earth, will be determined by what we do here and now.** If you are wrong, every child dies in hell. But if you are correct/ then every child lives for a lifetime and so to, will their children. If you are wrong, the world ends.

9. There is a crisis in the ocean. **WE CANNOT** live without that food source. **WE ARE** soon to be 7 billion people & are growing at a rate of 2 million more mouths to feed each and every week.

a. The oceans, and its life; are being raped, ravaged, and destroyed by a wide variety of failures, caused deliberately

by men. Learn, choose better, rebuild as best you can.

VIII) The solution is: **RESPECT AND REALITY, THROUGH TRUTH, DISCIPLINE, AND HONOR.** Building for life, rather than destroying everything you can now touch.

10. There is a crisis in government. The lies have festered long, and grown into cancers that threaten the very existence of life on earth. Those who lead, and have led throughout history are men/ *and for decades: ONLY “the university graduate”!* The end result is: we are surrounded by threats of extermination/ that we may or may not survive as life on earth.

IX) the solution: replace these men with women/ as **WE MUST HAVE DIFFERENT, and there is no other solution.** Women are different, and they will lead in different ways. They cannot do worse, than lead this entire world to the brink of collapse and extermination. How is it possible? The answer is, **THEY CANNOT** do worse! Men and the university are through leading/ they failed, and chose death to us all. **Look at the evidence.**

11. There is a crisis in the courtroom. The highest court in the land, the US SUPREME COURT refuses to obey the law/ as is proven in the docketed supreme court case 08-1339. Combined with the highest legal positions of authority, they chose to reject the first amendment, **and refuse your authority as a democracy: TO BE INFORMED, & to choose for yourself.**

X) The solution, remove these people from their office/ and describe their punishment: as criminals against the people. Find others, who do respect you, their oath, and our law.

12. There is a crisis in education/ in religion in government (evolution is, “just another story, based on lies”)/ in monopolies ruining the country, controlling the media, and selling the nation to foreign interests, or just plain greed: **just to name a few.**

XI) begin again, and choose for yourselves a new direction, method, and way.

**These constitute the recipe** for changing our direction, and our means to attain a new world, and a better life through peace and justice for all. **IT IS A CHOICE/ that you will make for yourselves in this day.** YOU CANNOT, run away or hide/ this entire world is completely dependent upon change. If you refuse change, “I say to you: the prophecies of Hell and Armageddon and more” will come VERY QUICKLY. NOT a religious threat, a reality proven by the choices men have made.

That is **NOT a threat, that is a fact conceived by the evidence & understood by the truth of what happens if you fail.** Men have prepared a civil war, by choosing to “get rich”/ even across an entire world. They have created machines to destroy you, and the only means to prove this is so; if you will not think/ is to let them gamble with every life on earth. Men have led you to genetic mutilation/ let the religion of evolution deceive you/ and much more. It is time to take your life back/ or lose it to absolute arrogance and complete disrespect for life.

## MAKE YOUR DECISION.

I am the plaintiff for the people, because this world is dying; and it is necessary. I am not here to lead you, NOT here to save you, NOT here to be your enemy or friend. Rather a dead world, has no place for anyone! HOW IS THAT, “not your fight too”?

I am the plaintiff for the people/ but you will determine if I shall have the power to hire or fire the attorneys who represent you/ or speak for you in court trials. YOU must choose by vote at the same time as you decide for redress, with more than 50% to give me that right for the purposes of these specific trials; nothing more, nothing less. I AM NOT your leader, and have absolutely no desire to be. **This is about life or death for this world/ and a new direction for the future; and that is exactly how I will use that authority, for LIFE FIRST. Nothing more/ and nothing less.** Not a wage or income/ but a realistic expense account, to cover the costs of living; because time will not be allotted to other things, like making money. If you provide the authority/ I will do the actual work for free. It is my contribution to life on earth! If you do not, then the attorneys or whosoever does represent you in court, will allow or do whatever they choose for you instead.

I will not be called to testify in redress/ rather I have given my full statement in the three web sites [www.justtalking.info](http://www.justtalking.info) [www.justtalking2.info](http://www.justtalking2.info) and where this will be found [www.justtalking3.info](http://www.justtalking3.info). That is enough, unless I choose to question you. I have further given in the 5 supporting sites found linked to the above web sites, any and all information

necessary to grant to you an understanding of what it would mean to give your authority to decide for this trial/ over hiring and firing those who do represent your interests. NOT leadership/ but the right to speak in trial, and the right to make the attorneys who speak for you do their job correctly, and without treason. Nothing more, nothing less. This is your decision/ not mine. Feel free to choose as you wish, I am not the determining factor: YOU can fight for yourselves.

*A warning to the defendant, as regards the personal aspects of this individual billing dispute.*

*UNTIL we enter within redress of grievances/ you have no right to charge attorney fees for “defending your industry/ they have not yet chosen to give you that right”. Consequently only what is fair and just in the matter of a billing dispute as is consistent with others, in trial over the disputed amount can be leveled at me. I do not ask you to represent your industry/ RATHER, I have respectfully submitted to this court, according to the law: a redress of grievances by the first amendment to the US constitution. You chose jury trial, your right as was chosen to protect your industry.
