you are instructed to notify all appropriate parties.

As a direct relationship with the courtroom hearings which have preceded this over the years since 2005: **each and every one demanding REDRESS OF GRIEVANCES, an IL constitutional guaranteed right to me and to every citizen DENIED.**

The fifth amendment/ guarantee, and instruction to you, our employees: that CANNOT LEGALLY be denied: by our constitution as a state called WE THE PEOPLE. The latest being case 10-MR-906 in Champaign county court. The reality is: THAT YOU, have failed to do your duty to me! THAT YOU have failed our democracy and rebelled against this people by denying their laws! THAT YOU, have chosen anarchy and the denial of "WE THE PEOPLE" as the true government here/ and set yourselves up as rulers over us instead. That is a traitorous act/ that is rebellion, and anarchy: that is treason to me, and to this people. And **must not be supported without a fight.**

Consequently this is now a legal tax revolt: NOT AGAINST TAXATION, (the deliberate work for society itself)/ but against those who believe they can rule us, steal our lives, and enslave our existence: instead of working for us all, as the constitution and the law allow. You have chosen a criminal route in denying to me **constitutional law/ as I am promised, BY THE FOUNDATION OF EVERY COURT: the GUARANTEED RIGHTS OF THE IL OR USA CONSTITUTION CANNOT be denied to me. THESE ARE, "the government": by the people/ for the people/ and of the people, in this state and this nation**

through fifth amendment state, and first amendment US law. **I am denied, BY TYRANTS, OR TRAITORS: Not by law!** *The price for that is a courtroom: WHEREIN I WILL BE TOLD HOW IT IS YOU CAN DENY A CONSTITUTIONAL LAW, and call yourselves anything but “traitors”.* YOU WILL, Prove I owe you anything, for economically destroying this state/ demeaning and denying this democracy: and shoving your own pockets with stolen goods. You will prove I owe you, FOR RIDICULING ME AND THIS PEOPLE, by pretending to work for our lives, by cheating us all, with your fantasies & the delusions of your own grandeur! Prove you aren’t: nothing more than a damn liar, cheat, whore, and thief! PROVE you are not a damn little group of rulers/ intending and participating in government for the deliberate purpose: of making us all SLAVES to do your bidding. *I prove to you the university of IL, Urbana; football stadium “press box” at a **cost of over 121 million dollar**; so some damn shithead fuck-ups can sit “like kings” for 6 arrogant afternoons a year PLUS, expenses, maintenance, costs.* ***Is nothing less, than slavery to me, and all who you robbed: to do what/ “if not play, kings and queens” over us ? And there are OBVIOUSLY MANY MORE, because you brought us all bankruptcy.***

I am through playing your slave without a legal fight. The constitution demands redress/ therefore you will give it to us all, as our guaranteed right; so that I can “pay the tax”. Because anything less is treason, for real! What then is the punishment? Let the people decide.

That is the foundation of my complaint. **The reality: BRING THE COURT TO ME, AND WE WILL FIND CONSTITUTIONAL LAW, or your TREASON!**

That is my demand: for a courtroom that is going to participate in constitutional law, AS IS OUR GOVERNMENT. *“The government” ain’t you/ you, are just a damn employee; trying to be rulers.* This demand does Establish: I have a right to legal representation, that representative, in the courtroom of this state and nation: **is our contract with you, the constitution of this state of IL describing what you shall do: by oath for us/** or be held accountable for, as your crime. Instead of slavery, the constitution DEMANDS: you work for us under these terms and conditions alone; **therefrom** you are allowed to tax. **You failed.** Your demand for taxation, IS ENTIRELY DEPENDENT UPON UPHOLDING THAT CONTRACT. The lawsuits I have presented as the litigant “James Frank Osterbur”: which proves, you have NOT contractually earned, any tax/ you have usurped your authority/ and rebelled against we the people instead. **You have**

earned **REDRESS: THE DEMAND FOR ACCOUNTABILITY** and the investigation, by evidence of your actions and reactions on our behalf, that prove **CRIMINAL** or not.

YOU DID NOT DO YOUR JOB, which means you shall NOT be paid. The work on our behalf, and for our benefit, **WHICH YOUR LEADERS SWORE**, would be done, is absolutely diseased with your own greed, arrogance, and thirst for power over us. **YOU FAILED DEMOCRACY: AND YOU STOLE OUR MONEY, clearly proven above, & by irrefutable evidence, AS IS BANKRUPTCY for we the people!** And riches, pensions, perks, bonuses, and benefits for the employees of government. By making us slaves.

YOU HAVE NO RIGHT TO DENY ME, my constitutional guarantee! That is tyranny and treason. *That means it is you who have broken the law, that means you are a traitor in rebellion against the constitution itself/ and it is you who owe me: nothing less than,* **THE RIGHTS I am promised.** Because you do not obey the constitution but deny it instead: you stand against the law that is our government. That means you do not collect taxation for rebellion. **This government is called WE THE PEOPLE. NOT YOU, the damn, scheming, bastard employee; who believes, “there is nothing they can do” . Rulers who collect for your own gluttony and purposes/ thereby robbing the people, to play god over them with your pride. That is anarchy.**

Until the day comes, when you do obey constitutional law: you have no authority/ because you chose to destroy the rights of every employee; by disobeying the constitution. As established by our foundation in government and law/ our constitution is that government. Your oath which says: there shall be penalties, gives us, the right to ask you, as employees working under that oath as a direction to the truth: did they choose obedience, did they do their duty: **to our constitution** of this state and nation. The question is: IF YOU DID YOUR JOB CORRECTLY, for we the people or not/ **by REDRESS we decide: NOT you?** Since you refuse the constitution/ A DEMAND you chose to accept/ **to get your jobs:** a reality, you swore to defend, protect, and obey: it is a prison cell you are owed. Or more correctly, it is the people who led you to defy the constitution, to disrespect and threaten our lives: that shall be tracked down as traitors/ terrorists/ and thieves: and dealt with accordingly. Let the people decide.

Open the door to constitutional law: OBEY IT, and then we will see who owes who! Bring me to court, by constitutional law, as we the people agreed: this will be our government/ or be refused. **Prove my error in court, and I**

will pay. But remember this: that it is you, who chose the time frame here/ it is you, that chose to not obey or recognize constitutional law/ and it is therefore TRUE: “I owe you nothing for interest, penalties, or fines”. **You chose** by your failures, your rebellion against the constitution, and as sworn oath diseased by your arrogance and greed/ not me.

WITHOUT THE CONSTITUTION PRESENT, as demanded in every case for redress by the litigant James F. Osterbur/ **IN EVERY COURTROOM/ AND OBEYED** as the law of this land by every judge, and every attorney; in this state or nation: **there is no due process of law.** THERE IS NO PROTECTION WITHIN THE COURT: for “REDRESS of grievances by the people as proven by [the extra-ordinary writ](#) assigned by this case”.

A demand: That recognizes the deliberate criminal act; against the democracy of this state of Illinois/ by refusing to acknowledge constitutional right and law. The denial of an oath of office. The intentional act, a betrayal of our democracy itself! In a courtroom provided by, WE THE PEOPLE of this state called IL.

the IL attorney general Ms LISA MADIGAN/ and her associate in charge of the courtroom during litigations Mr. Joshua I. Grant. Whose work address is: 500 S. Second st. Springfield IL 62706

the demand: you shall search for those, “hidden from view”; who are

directly responsible for interfering in our government, by constitutional law.

FOR, The traitorous act: TO DENY CONSTITUTIONAL LAW, AND thereby USE THE COURTROOM FOR FRAUD. Culminating in a CONSPIRACY TO *DENY A FOUNDATION LAW that is redress the fifth amendment of our IL constitution; as is proven by champaign county 10-MR-906.* By COLLUSION, the intent TO DESTROY THE CRITICAL TRUTH OF this, our CONSTITUTIONAL GUARANTEE; as is redress. The CORRUPTION identified, BY FAILURE TO UPHOLD A **SWORN OATH** TO “PROTECT/ DEFEND/ AND OBEY” THE CONSTITUTION OF ILLINOIS, first/ not last. And the reality of criminal intent to rule over “we the people”/ instead of obey our law, and fulfill our contract as constitutional government; with each other called democracy: open rebellion. By failing constitutional rights as guaranteed to each citizen. By our agreement as a state or nation, called we the people: TO CONTROL THE employees of this state called IL; through the constitution and its demands; denied . **BY RULING OURSELVES,** ACCORDING TO THIS CONSTITUTION; defied.

Established by the irrefutable evidence of several cases involving the litigant James F. Osterbur; each demanding redress for the people of IL, or this nation. The act of treason becomes clear in the repetitive denial of the constitution by these attorneys. A war against the constitution by denying its existence in a courtroom of law, and its direct representation of rights guaranteed to me, by that courtroom of law; disavowed. Adhering to the design and rebellion of those who would be “our rulers/ instead of our employees”; treason the intent to destroy “we the people rule ourselves”. . Giving aid and comfort to all who have so clearly: **STOLEN OUR ECONOMIC LIVES** (protecting them, and not us)/ **DISGRACED OUR DEMOCRACY** (hiding them from accountability/ rather than supporting democracy)/ **AND GIVEN THEMSELVES ALL THE GLUTTONY AND POWER THEY COULD STAND** (redress demands the truth by investigation and court). The above example of a football stadium extension for the sake of a tiny few/ for six afternoons a year: is an absolute description of **TRUE CORRUPTION AND DESTRUCTIVE POWER, over the people/ INSTEAD OF DEMOCRACY: WHICH MEANS, “FOR THE PEOPLE”.**

THE FOUNDATION of case 10-MR-906 which became clarified and established in a courtroom of law, by the prepared WRITTEN STATEMENT;

given to the defense and the judge during trial on 11/ 23/ 11 which reads: quote,
*“In this courtroom E, in Champaign county IL/ on this day:
I am here for redress, the state of ILLINOIS fifth guarantee to
the citizens/ I am here for redress, the United States of
America; first amendment legal right, to assemble the people;
establish our grievances: and demand the investigation of what
we believe is wrong, with this state and nation: BY LAW, and
constitutional right. ALL other issues, involved in this case:
are abandoned at this time.”*

Shall prove, that it is the law that has been denied. It is our democracy that is in shambles, because “an organized crime exists” in betrayal of our society: to STEAL OUR DEMOCRACY from us/ to steal our future/ to steal our lives; by betrayal, AND BY THE REFUSAL: to accept we the people are OWNERS HERE. NOT “you the employee”. As so clearly demonstrated by the expenditure above, by our “representatives” **WHO CHOSE NOTHING for “we the people” / but chose every form of gluttony and pride for a tiny few in university instead: who then did hand us the debt, for their delusions in grandeur. THE RULE IS: that we pay taxes, for the benefit of ourselves and our society and our future! We the people have NEVER agreed: “you can give your idols, your fools, your failures, and your idiots: our money, to play king or queen”. WE ARE BEING INVADED, by those who are at war with this society, TO MAKE US THEIR SLAVES! There is no immunity for defying our constitution/ there is no sovereignty or authority over the constitution: it is the law, it is our government, as WE THE PEOPLE: and we demand obedience to your oath.**

The state police are then called to establish all necessary forms, addresses, etc; to me/ or procedures for them: to bring the guilty parties to trial. So that any and all possibilities of “less than perfect” are resolved: by their intent, to serve, protect, and obey the constitution/ thereby the people; of this state called IL.

CALLED AS WITNESSES, as representatives for, WE, the PEOPLE; and OUR CONSTITUTION OF THIS STATE OF ILLINOIS: to insure OUR DEMOCRACY shall be protected/ OUR CONSTITUTION shall be obeyed/

OUR LAWS shall be enforced/ AND OUR RIGHTS shall be upheld. TO DEMAND: those who have made an oath, SHALL keep it, in full! Or pay the price of their failure: EQUALS UNDER THE LAW. Do we not go to jail for breaking contracts/ oaths/ laws/ and performing acts of betrayal against this society? Indeed “we the people, do”. Justice is blind, to position/ power/ and money is that not so! PROVE IT.

I do not request a settlement hearing/

**I DEMAND a legal hearing in a court of law: to decide as
indicated throughout “this conversation with you”: if you OWE ME
CONSTITUTIONAL LAW. This demand for a constitutional guaranteed**

right, to each and every citizen/ that has been denied to me. If you as an employee of our government called WE THE PEOPLE/ are entitled to participate in, or make a decision on your own, to destroy or deny a foundation principle of the UNITED STATES CONSTITUTION; which is first amendment redress of grievances LAW. As have the courts.

A COURTROOM CASE: To decide and demonstrate the reality of our contract as THE government of this nation, through WE THE PEOPLE: asking if our employees have kept your oath. The oath to this nation to gain your job; and the reality of conduct by its truth indicating IF all our employees for this nation, have obeyed/ or denied that oath.

A COURTROOM CASE: To decide the critical responsibility of an oath to protect, defend, and obey the constitution IN ITS ENTIRETY/ thereby reaping the reward of a salary for that work and its consequent employment. **OR IN THE CONTRARY, having failed to uphold the oath, the oath you:** declared would be done for this government, our constitution of this UNITED STATES, and we the people. When failure: **Denies your right to collect or distribute taxes:** because you are in open rebellion against the constitutional law, against we the people, and our democracy; that gives you your job.

Failure to obey your oath is a criminal offense/ failure to obey and respect the constitution is a sign of treason, the act of a traitor to this nation. A reality that shall not be payed. A truth that MUST be defended against, as is being done here in this demand for court today. Prove your oath/ prove the constitution is obeyed as sworn.

DUE PROCESS as assigned to you and declared a constitutional right to me under the 7th amendment grants to me a courtroom of law, for financial and more important values as is freedom, liberty, and literally defense of this nation. The first amendment grants me “legal redress of grievances”. The right to call the people together in a legal forum to decide if: we will demand accountability and investigation of the evidence: proving what is or is not true. The thirteenth amendment declares I shall not be a slave/ which is denied to me, by the fact that our currency HAS BEEN SO INFLATED over the last few decades that the federal reserve now claims an asset value of over 154 trillion dollars, divided by 311 million citizens that is nearly one half million dollars per citizen, babies/

prisoners/ and all. Divided equally every single citizen should have \$500,000.00/ IT AIN'T SO. By declaring that money AS debt instead of inflation: WE HAVE BEEN ROBBED. Instead of reaping reality/ the few in powerful positions took all that inflation (*the claim of money is: the people will work for me, and surrender their resources and property to me*) for themselves: and gave us the debt, claiming they are rich/ and we are poor. IT IS MONOPOLY MONEY, it is counterfeit money/ it is a blind and deliberate theft and confiscation of property and the value worked for and secured, from every life in America and many around this world. And now there exists, many around this world who believe we shall be their slaves too. It is a redistribution of our wealth as citizens of this nation/ TO THE WEALTHY instead. It is anarchy and the delusion of numbers. It is treachery, trickery, and treason. YOU STOLE, or more correctly YOU HELPED the others steal; by destroying the value of our currency, and declaring yourselves "rich". That fact requires a courtroom/ and that is the only compromise I make.

While it is true I cannot stop you from stealing more from me/ INSTEAD OF PROVING YOUR RIGHT in a courtroom of law; you are the "current mafia/ organized criminals" in charge. That fact simply hinges on a courtroom: it proves a criminal conspiracy/ an absolute corruption/ and a blind arrogance that is building toward civil war. OR, you will prove obedience to the law, by providing the courtroom I seek: wherein redress and other foundation principles of our constitution SHALL rule.

Although civil war is imminent, without justice/ it is not from me. **Because if the law is not substantial enough to move this society/ then I just won't belong to it anymore; you will be abandoned to your fate.**

I DEMAND THE LAW CALLED CONSTITUTIONAL FIRST AMENDMENT REDRESS OF GRIEVANCES SHALL BE KEPT, BY OUR EMPLOYEES. That is my demand.

Your failure to properly respond: recognizes that you have refused to enforce/ or participate in enforcing, *a law of the constitution which governs this nation*. You have chosen to deny a declared "GUARANTEED RIGHT" of every citizen in this nation. You have abridged the privileges (*my right to redress trial/ the contract we THE PEOPLE, have with our employees that states: YOU WILL OBEY THE CONSTITUTION*) and the immunities of legal protection provided by our access to a courtroom, and its provision for DUE PROCESS provided to me.

Litigation prior to this day, and during this day ALL PROVE the court

refuses the law. **YOU HAVE NO SUCH RIGHT.** Nor does any employee particularly in the IRS have a right to collect taxes used specifically for the destruction of democracy or the denial of our constitution or our rule as **WE THE PEOPLE** over you our employees.

Employment of persons WHO DO OBEY OUR LAW, we are obligated to pay. If however you deliberately refuse or fail to obey the law/ then you are rebels in open attack against this nation, **bent on anarchy and destruction: of a deliberate law, a foundation of our nation, our right to accountability and the rule called democracy.** For what do I owe you money/ why should I pay for the bankruptcy of this nation/ how should we repay, for the endless threats for extinction/ the gambling with an entire planet/ the failure of fools, bastards, and whores: who chose to “play god” with our lives? Because that is where our taxes went/ therefore a demand or call for tax revolt.

Exactly what did you do, that was within constitutional intent: *the design of the preamble of the constitution to govern direction and law.* In case you are ignorant: the preamble correctly interpreted says, “**LIFE must come FIRST**, you fail/ it says, **PROTECT THE CHILDREN**, you fail/ it says **DO YOUR BEST FOR JUSTICE AND SOCIETY**, you didn’t even try, choosing greed and destruction instead. ESTABLISHING JUSTICE is proven a fraud and a deceit by ridicule. *Our employees run a courtroom in absolute defiance to constitutional law; proven by irrefutable evidence in case after case throughout all levels of the judiciary.* **PROVING CONSPIRACY AND CORRUPTION AND COLLUSION IN OPEN DEFIANCE OF THE CONSTITUTION OF THIS UNITED STATES OF AMERICAN.** Which means your actions are as traitors. Why do I owe you money for that/ do we not owe you a prison cell instead. I stand in this matter; as a citizen fighting for this democracy and its law. That sure as hell, ain’t you.

You refused justice for the people and chose GREED for the few. You refused reality and chose DELUSION for loans and guarantees and securities and everything else, pretending that wall street was anything but a counterfeiter (which it clearly is). Instead of reality, as is “FAIR PLAY” FOR ALL/ you made the few: “our rulers”, by stripping the majority of everything they worked for or owned. Foreclosing, destroying, denying, and debilitating an entire nation: FOR YOUR FANTASIES (nobody has to pay [except the slaves]/ we can pretend “debt don’t matter”). In every sense of the word: the employees of

this government: which is called the contract of our constitution/ our agreement, as the law identified between ourselves as, we the people. Our

restrictions upon the employees who would work for us only by sworn oath to obey that constitution in full/ or face prison.

HAS BEEN TRAMPLED UPON, by our employees, who stole everything they could find; and when they could not find more; THEY STOLE FROM EVERY CHILD. And when that was not enough, you stole from the world. and when that was not enough, you stole the homes and the lives which are a foundation to this nation. **As every anarchist does: FULLY INTENDING** to tear it down, by your dreams and images of playing god over our head/ by making us your slaves, with numbers without end for you/ and endless work and loss for us. **“You get all the money”/ we get all the debt: what could be more clear!** and then comes taxes, to steal the rest.

I DEMAND A COURTROOM: WHERE THE LAW, CALLED REDRESS OF GRIEVANCES IS OBEYED! **OR** you prove that the law written into first amendment guaranteed rights: is in error! WHERE THE PEOPLE HAVE THEIR SAY, AS IS REDRESS: without open rebellion and a judicial war, against the law. **One way or the other, the answer here is: this choice (our future/ the investigation of our past) belongs to we the people, it is not yours. It is ours: as the constitution provides for the safety and security of this nation: called DEMOCRACY/ by redress.**

There is no other settlement. Prove you obey the law/ or prove the constitutional law, that governs our employees: thereby telling our employees what they **MUST DO FOR US**, is wrong.

Prove an oath is without meaning/ or the evidence of complete anarchy and open rebellion is **NOT** traitorous.

Prove you didn't steal the entire nation blind, and bankrupt us all, with your delusions and your fantasy and your disease of a diploma that knows nothing, for the sake of life, duty, honor, respect, or anything else of value to a nation, a world, or life itself. “Toys don't count”.

Prove your gambling with this entire earth, threatening every life with extreme experiments is NOT AGAINST the very nature and reality of our agreement as a people.

Prove securing the blessings of liberty to ourselves and our posterity; has not become: nothing more than a sewer, for the filth of your disease. The disaster of minds so disfigured with pride, greed, and selfishness: you cannot comprehend **LIFE MUST COME FIRST**. Shame on you all.

Do it, and I will pay the taxes without further protest. Fail, and as is

common to thieves: you will steal instead. It's a choice.

Once that is done. After a courtroom of law decides the constitutional demand of a guaranteed right; and the contractual duty of both an oath, and your employment. THEN and only then, shall we talk about how much money you owe me/ instead of I owe you: *for insisting you shall NOT BE "our" RULER*. Rather; *all* shall return to being our employee, and do what you gave your word, "YOU WOULD OBEY THE CONSTITUTION"/ **and thereby, accepted the threat of prison if you did not do so**. Did you not consume my life, with your failures. How is this my job/ because you refuse to obey the law, and refuse to obey your oath/ and refuse to surrender a courtroom to me as is DUE PROCESS/ and SO MUCH MORE. You owe me, and this nation. Let the citizens themselves decide how much/ let the evidence decide who goes to prison in this day. **Let the truth and nothing but the truth decide.**
