MOTION FOR THE SUBPOENA OF EVIDENCE

The elemental reality being: <u>WE HAVE BEEN ENSLAVED ENOUGH/</u> and there shall be NO MORE, "University of IL football stadium, 121 million dollar additions/ plus costs".
